Canadians need to be asking some hard questions of our government...


## Are the Covid Vaccines Really 'Safe and Effective'?

## Why is the Media NOT Reporting the Thousands of Adverse Reactions?

The Covid vaccines being used in Canada are not, in fact, vaccines. These injections are more properly called 'mRNA gene therapies' and we don't know what the long-term effects of these gene therapies are.

**As of the time of this writing in July of 2022, the Vaccine Adverse Events Reporting System (VAERS) shows over 1.2 million adverse reactions and almost 28,000 deaths. This is in the U.S. alone.**

In 1976 the U.S. government rushed through a swine flu vaccine. It was withdrawn after just 32 people died.

*It is vital to note that these adverse event reporting systems are voluntary on the part of doctors who make entries to them. A Harvard Medical School study found that the events reported likely represent less than 1% of the actual number of severe adverse events.*



## Where Are the Extra Deaths?

If there was a deadly pandemic we would see an increase in the All Causes Mortality Rate, but according to data from Statistics Canada, there has been no such increase.

## Why Did Pfizer Try to Bury Their Trial Data for 75 Years?

## A Catastrophic Situation

Insurance companies report a staggering 40% increase in death among people aged 18-64 since the start of the 'vaccine' rollout, while pointing out that a mere 10% increase would indicate a catastrophic, once in every 200 years, situation! 40% is unheard of.

Now our government wants to bring in Central Bank Digital Currencies (CBDCs), which will allow them not only to track every purchase you make, but limit what and how much you can buy.


And Universal Basic Income? A poverty level living in return for total compliance with government mandates.

## Are the Covid Vaccines Really 'Safe and Effective'?



Gov. of Canada Data Showing the Majority of Cases Now Among the Vaccinated (see page 22)

The government is intentionally providing misleading figures. Their case by vaccine status information up to the end of 2021 reported all cases since the start of the 'pandemic', when the vaccines were not introduced until late 2020. Starting 2022 (after they were caught at this) they started reporting this data from December 2020, the start of the vaccine rollout and after the majority of deaths had already happened. Look for the footnote below the chart on the 2022 data. This footnote does not appear prior to 2022 reports, which is why cases among the vaccinated jumped dramatically in just one month.

## Where Are the Extra Deaths?



Gov. of Canada All Causes Mortality 2000 to 2020

While you will see a jump in deaths in 2020, note that this is normal. You will see a similar pattern in 2000 to 2002, 2003 to 2005, 2009 to 2011 and especially 2015 to 2017. In each case, the middle year was a weak flu year, which is why there was little to no increase in deaths from the first to the second year. Many elderly people survived who would otherwise have died from a more virulent strain of the flu. In the final year in each 3 year set, when a jump in deaths is seen, this is due to more virulent strains such as H1N1 being present. What the news did not report is that 2019 was a weak flu year, while H1N1 was present in 2020. This explains why deaths dropped in 2019 from 2018, but rose sharply in 2020. This is largely what accounts for the extra deaths that year, not Covid-19 which we've already shown is nothing but a 'weak flu'.

In addition, at the time of this writing in July of 2022, the government of Canada should have released the All Causes Mortality figures for 2021 months ago. They have not because it shows a drop in mortality which fits the pattern shown above. When a trend line is run, such as we have done in our chart in this brochure, it shows no unusual increase in deaths. They don't want you to see that. (We had a former government data expert analyze the last few months of 2021 so we could generate our chart).

## A Catastrophic Situation



Life insurance companies are showing a 'catastrophic' increase in deaths in 18 to 64 year olds. This is since the vaccine rollouts.

There are two important take-aways from this article (there are many other articles). First, the increase in deaths among working age people did not start in early 2020 with the advent of the so-called pandemic, but in 2021 after the vaccine rollout. Second, that deaths in 2021 and 2022 'from Covid' are down dramatically, but deaths are up to a 'catastrophic' degree. So what is killing otherwise healthy working age people? Certainly not Covid. The only other new variable is the 'vaccines'.
