This has been a crazy week with all sorts of wild things happening. And yet the one thing I have realized, is that for all the shock and outrage we have had to contend with, such as the slapping of tariffs on Canada and the fight with Zelenski in the Oval Office, there is always more to what's going on than we think.

Things are very seldom as they seem and there is always drama, intrigue and (sadly) corruption at so many more levels than we know or read about in the media.

John Leake wrote about this very topic on his FOCUS POINTS substack on Tuesday in which he said: "*Cicero is alleged to have said that 'Rome is made of marble but built on a sewer,' referring to the corruption that was endemic to*

the world's power center. When institutions and powerful individuals operate for long periods without scrutiny, they may be tempted to commit such outrageously corrupt acts that disclosing them to the people becomes an insurmountably difficult task (as Elon Musk is currently coming to realize).

A major problem that has always plagued electoral politics is that it is impossible to get elected without a large war chest of money, and equally impossible to govern without maintaining friendly relations with big money guys. "Money makes the world go round" is not just a folksy saying, but a hard and perennial truth. If you don't believe that, try to accomplish anything that involves persuading large groups of people and see how far you can go without financing. This means that candidates—even candidates with the best motives and intentions—will inevitably be beholden to big money interests.

For years there has been a lot of consternation about the refusal of federal agencies such as the CIA and FBI to disclose documents pertaining to the JFK assassination and Jeffrey Epstein. Guys like me have also noticed how the U.S. government, including Congress, can't ever quite seem to get to the bottom of the origin of SARS-CoV-2.

The truth of these stories probably carries incalculable liabilities—liabilities that would call

into question whether the involved institutions should be allowed to continue existing.

Disclosing the truth could also instantly demolish the persistent naïveté that enables most people to maintain their allegiance to their governments and to believe the endless train of BS that we are told every day about everything.”

This plague of corruption and the powerful influence of Big Money explains why Pam Bondi can't get, or release, the Epstein files, and why there is so much coordinated resistance against Musk and his team at DOGE.

Uncovering these deep underlying motivators and influences helps us see and understand what the real reason is for things happening (or, as in the case of the Epstein files, not happening). So, can it help explain the whole mayhem we are facing with the imposition of tariffs on Canada?

For us these tariffs are a big one, because they affect us personally and there's no doubt we will almost immediately start to see the price of imported products from America, especially food, going up significantly.

Mark Carney, who will almost certainly become our next Prime Minister as early as next week, says that the tariffs are *“the biggest threat to Canada since World War Two.”* while Marc Miller (our Minister of Immigration, Refugees and Citizenship) agrees and has said that they *“will put more than one million jobs at risk.”* It all sounds terrifying, which is why we have seen the sudden surge in patriotic fervour and the spike in anti-American rhetoric.

But this is a naive reaction, which reflects a populace who, after all this time, still believe what they are fed by the mainstream media and their government financiers.

To me, the much greater threat to Canada's economy is not the tariffs, which will likely be watered down and balanced out over time. It is instead the much greater attraction of America as an investment destination in comparison to Canada with all our restrictions and bureaucracy. Trump's tax incentives, slashing of red tape and reduction of corporate and personal taxation is already driving corporate investment money out of Canada and into the US, and that will continue for likely the next eight to twelve years. With little to counter Trump's bullish incentives I think that economic drain will indeed be the 'greatest threat to Canada.' Thank God Poilievre is more business-friendly and understands how to attract investors.

Lawyer Lisa agrees with my thoughts on this and wrote on her substack earlier this week that the Canadian response to Trump's tariffs was a classic example of *“how to tank the economy for dummies.”*

Her recommendation instead is that our (presumably new Poilievre government) immediately dump all carbon tax which would more than offset the tariffs for consumers and give lift to affected industries with targeted subsidies, lower taxes on investments in infrastructure and genuinely help small businesses to thrive as they are the engine to economic growth. She goes on to describe Trudeau's response to Trump and the Liberal management of the economy as nothing short of *“communist asset grabbing, no different than Stalin but done through fiscal policy and a media sell job.”* I fear she might be right.

Now, to illustrate how, with regards to the tariffs specifically, 'things are very seldom as they seem,' on Wednesday, our first full day of tariffs, Donald Trump posted the following, *“Justin Trudeau... was unable to tell me when the Canadian election is taking place, which made me curious, like, what's going on here? I then realized he is trying to use this (tariff and border security) issue to stay in power. Good luck Justin!”*

So, maybe, as Trump seems to have concluded, all this hyping of the tariffs and intransigence when it comes to securing the border is just a political ploy by Trudeau to gain the sympathy vote and to stay in power, albeit a bit more subtle, 'behind the scenes' type of way (much like how Obama did in during the Biden administration)?

That point about securing the border is important as most Canadians seem to have already forgotten that the tariffs were just the result of our 'post-nationalist' lack of border control which resulted in the fentanyl crisis, and that really is Trump's core problem with Canada. Or did Trump see the opportunity to simply assimilate Canada given that by our Prime Minister's own admission we were 'post Nationalistic' and ready for the taking? Maybe...

Now, while these political machinations intrigue me, I do try to keep our focus in this newsletter on matters of health and healthcare, so while I believe we are facing a significant economic threat, this 'border issue' definitely has a huge public health impact. That is due primarily to the scale of drug-overdose deaths that we have suffered over the last few years. Sure, it is

driven by the Chinese inflow of deadly drugs destined for the USA. However, we can't ignore the impact of the Trudeau government's disastrous 'safe supply' initiative, which, combined, has killed (as a proportion of our comparative populations), five times more Canadians than Americans.

Again, Lawyer Lisa sums this up very succinctly when she says, *"If 110,000 Americans died of fentanyl overdoses last year you'd expect Canada to have 11,000 fentanyl overdose deaths. Well it was 50,000 according to a recent Jordan Peterson post. Trump should ask Trudeau to clarify what he thinks of this junk killing Canadians, because maybe there's a reason we don't have action on fentanyl here. And Dictators don't call elections, instead they close Parliament like Trudeau did. Remember "resign?" [So, is this just a] cover for the next operation?"*

Given how things are very seldom as they seem, all this outrageous drama could well be a 'cover for the next operation,' whatever that may turn out to be, although at this early stage, it does seem to be an attack on our food supply chain, by both the tariffs and bird flu.

It is hard to keep up with it all, but one thing is for sure, we always need to look beyond the headlines and the story we're being told by the media to better understand what is really going on and why. Only then will we be able to take control of our own lives, our own health and our own personal success and happiness, irrespective of the maelstrom of scary headlines that are swirling around us, screaming for our attention and our wide-eyed panic.

And panic is not necessary. It is Saturday after all, the days are getting longer, the weather is getting warmer and most of us have the day off tomorrow, so take a deep breath, relax and recharge.

Wins of the Week

Here is a spread of some of the provincial, national and international wins we had this last week which are helping to keep things going in the right direction...

- 1) In particular, there's good news for Alberta and Saskatchewan; On Monday President Donald Trump said he wants the Keystone XL pipeline, which would transport crude oil from Canada to the United States, built as soon as possible, years after Biden scrapped the project. *"The company building the Keystone XL Pipeline that was viciously jettisoned by the incompetent Biden Administration should come back to America, and get it built - NOW!"* Trump wrote in a post on Truth Social, on February 24. It is believed that higher volume and more cost-effective means of transporting Alberta's crude to the Texas refineries was part of Danielle Smith's recent discussions with Trump. This announcement is a positive sign that the US President is willing to work with Alberta's Premier on regional energy security which will of course be very good for the Albertan and Canadian economy as a whole.
- 2) The BC government will finally end a component of its so-called *"safe supply"* program after extensive reporting that showed hard drugs distributed by pharmacists were being diverted to the black market. BC NDP Health Minister Josie Osborne said the practice of allowing users to take their prescribed opioids home will be limited to a *"witnessed model,"* meaning users will have to be watched by health professionals as they consume the drugs. Data released by the BC Emergency Health Services shows that calls for drug overdoses and poisoning have almost doubled in virtually every major municipality in the province since the *"safe supply"* program was originally introduced in 2020.

- 3) A formal notice, signed by 800 scientists and policymakers, has been delivered to the governments of 24 countries, including Prime Minister Trudeau and every federal MP in Canada. This notice demands that our federal government immediately halts the use of the Covid-19 'vaccines' and boosters and that they launch a thorough investigation into the approval and deployment of these very questionable 'treatments.'
- 4) Going over to the US now, The Florida Senate has passed a bill banning geo-engineering and weather modification, repealing existing licensing and reporting requirements, and prohibiting activities that alter temperature, weather, or the intensity of sunlight within the state's atmosphere. This is all specifically targeted at aircraft-dispersed chemtrails, which many Canadians still consider to be a conspiracy theory. However, you have to ask how it could possibly be a 'conspiracy theory' if there has been "existing licensing" for it in Florida (and likely every other state in the USA).
- 5) Utah lawmakers last week voted to pass the first US statewide ban on adding fluoride to public water systems. The Utah Senate voted 18-8 in favour of the measure after it passed in the House. Once passed into law this will end community water fluoridation in the entire state of Utah. Commenting on this, FAN Executive Director Stuart Cooper said, *"This is another significant victory for the public, who didn't sign up to have a developmental neurotoxin and endocrine disruptor added to their drinking water... We're watching water fluoridation unravel globally in real time."*
- 6) Seventy-four percent of elementary school personnel surveyed in California (yes, that's far-left California!!) do not believe their schools have the authority to deny medical exemptions, and over half opposed Covid-19 vaccine mandates for students, according to a study funded by the National Institutes of Health. Respondents expressed concerns about the safety of vaccines for children, with 42% *"concerned that children's immune systems could be weakened by too many shots."* Thirty-two percent thought immunizations do *"more harm than good"* and 28% said they did not believe vaccines strengthened the immune system. - 7) Robert Kennedy Jr. has issued a 90-day stop-work order on the HHS contract with American biotech company Vaxart Inc., which is developing an oral Covid-19 vaccine. The pause comes just days before ten thousand participants were set to begin clinical trials on Monday. According to HHS pausing the trial was a necessary decision given its flawed study design, lack of a placebo group, and dangerous mechanism of action which could have seriously harmed the ten thousand participants. Instead of comparing the Vaxart product to a placebo group the original study design would have compared it to 'an approved mRNA injection.' Given the disastrous safety profile of mRNA injections, this study design would not reveal the true risks of this oral vaccine which is the main reason why it has been paused for more careful evaluation.
- 8) On the subject of RFK Jr., in a widely-viewed video shared on social media, the US Secretary of Health and Human Services, Robert Kennedy, Jr., asserted that the majority of vaccines – including those he sees as being mandated for infants – have been developed primarily to create profits for Big Pharma. *"Most of the vaccines after 1989 were added not for public health reasons but for pharmaceutical profit reasons,"* said Kennedy.

How I Wish Kennedy Had Responded to the Measles Outbreak

In response to the recent “outbreak of measles” in Texas, and the death of a child purportedly from measles, Robert Kennedy Jr., the newly confirmed Secretary of Health and Human Services responded by publishing an opinion piece on Fox News on March 2, 2025. (<https://www.foxnews.com/opinion/robert-f-kennedy-jr-measles-outbreak-call-action-all-us>).

In the article Kennedy states:

“In response to this outbreak, I have directed the Centers for Disease Control and Prevention (CDC) and the Administration for Strategic Preparedness and Response (ASPR) to work closely with the Texas health authorities to provide comprehensive support. HHS’ efforts include offering technical assistance, laboratory support, vaccines, and therapeutic medications as needed.

As healthcare providers, community leaders, and policymakers, we have a shared responsibility to protect public health. This includes ensuring that accurate information about vaccine safety and efficacy is disseminated. We must engage with communities to understand their concerns, provide culturally competent education, and make vaccines readily accessible for all those who want them.

It is also our responsibility to provide up-to-date guidance on available therapeutic medications. While there is no approved antiviral for those who may be infected, CDC has recently updated their recommendation supporting administration of vitamin A under the supervision of a physician for those with mild, moderate, and severe infection. Studies have found that vitamin A can dramatically reduce measles mortality.

Parents play a pivotal role in safeguarding their children’s health. All parents should consult with their healthcare providers to understand their options to get the MMR vaccine. The decision to vaccinate is a personal one.

By 1960 -- before the vaccine’s introduction -- improvements in sanitation and nutrition had eliminated 98% of measles deaths.

Good nutrition remains a best defense against most chronic and infectious illnesses. Vitamins A, C, and D, and foods rich in vitamins B12, C, and E should be part of a balanced diet.”

I support these comments. They are sensible, factual, respect informed consent and parental authority, and contribute to a richer understanding of measles infection.

Most notably, I appreciate that Kennedy:

- Acknowledged that the decision to vaccinate is a personal one
- Acknowledged that measles mortality declined by 98% prior to the introduction of a measles vaccine; that the decline was a result of improvements in sanitation and nutrition
- Acknowledged the importance of good nutrition, most especially Vitamin A, C and D in supporting immune response
- Acknowledged his responsibility to ensure that accurate information about vaccine safety and efficacy is disseminated

My disagreement and disappointment with Kennedy’s messaging is the following:

- Stating that “this outbreak has claimed the life of a school-aged child, the first measles-related fatality in the United States in over a decade.” It would appear that it is premature to conclude that measles was responsible for the death of the child.
- Stating that “Vaccines not only protect individual children from measles, but also contribute to community immunity, protecting those who are unable to be vaccinated due to medical reasons.” These two claims - protection from measles and community immunity - are questionable claims that reinforce pharma propaganda that “all vaccines are safe and effective”

and that “we have a responsibility to be vaccinated to protect others who are unable to be vaccinated”. This messaging is used to justify vaccine mandates and violate informed consent.

- Stating that actions will be taken “to contain the outbreak” and “bring it to an end”. What is implied is that government actions can stop the spread. Where have we heard that claim before with disastrous consequences?
- Nowhere does Kennedy speak to the “elephant in the room” that none of the childhood vaccines have been proven to be safe and effective using a true placebo; that vaccine induced immunity is temporary at best; and that measles outbreaks may be due to vaccine failure and shedding by those recently vaccinated with a live vaccine.

My perspective is that Kennedy missed an opportunity to educate the public on the many aspects of the vaccine paradigm that are not well understood.

In response to the purported measles outbreak, I wish Mr. Kennedy would have responded this way:

The loss of a child is always tragic. My condolences to the family.

As Secretary of Health and Human Services I’m committed to supporting efforts that contribute to the health and safety of our children.

I believe it is important that we not make definitive statements and reach conclusions before we have fully examined the evidence. We need to understand whether this child died ‘because of measles’ or ‘with measles’. It’s important we know the cause before we act and not assume something that may not be true.

We have been conditioned to believe that all incidences of measles are a threat that must be avoided. This is simply not true. Measles is a childhood infection, and in previous generations, virtually all children contracted measles with relatively low incidence of serious adverse effects or mortality.

We have also been conditioned to believe that all vaccines are safe and effective for all

children. This too is simply not true. The media and vaccine proponents would have us believe that any death from measles is unacceptable because there would be no deaths if everyone accepted the vaccine. The evidence doesn’t support this message.

The Vaccine Adverse Events Reporting System (VAERS) provides the following data: As of June 28, 2024, there have been more than 113,740 reports of measles vaccine reactions, hospitalizations, and injuries including 563 related deaths. Approximately 50% of those adverse events occurred in children under three years of age. A 2011 HHS study acknowledged that less than 1% of vaccine adverse events are reported so these numbers may be 100X higher. Also, it is important to note that the measles vaccine has never been proven safe against a true placebo.

Has the measles vaccine reduced the incidences of measles? With the rapid decline of measles prior to vaccine introduction, and the failure of the CDC to compare outcomes of vaccinated and unvaccinated children, the answer is “maybe”. When the vaccine was introduced in the 1960’s the claim was made that measles would be eradicated with one shot by 1967. Clearly this claim was unfounded.

The vaccine does not confer life-long immunity, whereas recovery from natural measles infection confers life-long immunity. Even more important is that mothers who have been vaccinated for measles do not transfer long-lasting maternal antibodies to their infants which protects their infant in the first few months of life.

The most important question is whether our children are healthier as a result of the measles vaccine? The fact is that that this research has not been conducted by the CDC to answer definitively. We ought to measure the health of children by more parameters than simply whether or not they receive a vaccine.

The undisputed fact is that our children are sicker today than previous generations. More than 60% of children in America today have at least one chronic health condition. The amount of asthma, allergies, autism, seizure disorders, eczema, juvenile diabetes, cancer, obesity, neurological and immunological disorders, and other serious health conditions including Sudden Infant Death Syndrome (SIDS) is far too common in children today.

The question is why?

What is contributing to this significant decline in our children’s health?

Is it the lower quality of our food and diets? Is it the significantly increased number of vaccines given to our children? Is it the dramatic increase in EMFs from wireless technology? Is it the ubiquitous use of pesticides and herbicides in our food production? Is it microplastics? Contaminated water? Depleted soils? Contaminated air?

In my role as Secretary of HHS, I intend to find out and no industry, product or policy will escape evaluation of health and safety.

I know that it's difficult for some people when they hear me questioning vaccine safety, efficacy and necessity. But if we are going to make decisions based on the evidence rather than ideology, it's important that we have the courage and the humility to ask these important questions.

In my role as Secretary of HHS, I intend to ensure the vaccine industry does what it claims to do and does it safely. I will make decisions based on the evidence, not media or industry propaganda. I refuse to accept the merits of vaccination on faith. I refuse to forsake accountability out of fear of being labeled an "anti-vaxxer".

I know that parents who vaccinate their children sincerely believe they are protecting their child from harm. They believe vaccines will provide a type of health insurance, shielding their child from disease.

I think it is important that we push beyond using "belief" as the basis for the vaccine decision, and instead decide from a place of information based on quality scientific evidence. Parents need good information to make informed risk-benefit decisions.

It's critical that we make important medical decisions, not because we are afraid, but rather because we are well-informed.

Is There Any Link Between The Recent Rash Of Aircraft Accidents, The Health of Pilots And The Covid Jabs?

Yes, it looks like there is, and this is leading to a major concern about aviation safety, which was once again propelled to front-page news with the crash of Delta Airlines flight DL4819 in Toronto a few weeks ago.

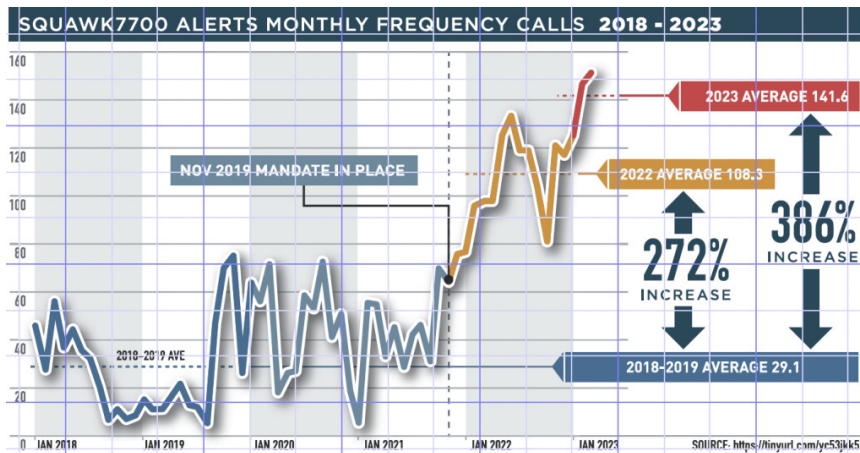
The video footage of the crash is shocking with the aircraft coming in to land seemingly under full control. But instead of flaring back at the last second to ensure a smooth touch-down it continued its trajectory and hit hard, snapping off its right wing and then rolling over in a massive balloon of smoke and flame. It was as if the aircraft was on auto-pilot and didn't see the ground coming up. Or was it the person behind the controls who didn't see the ground coming up...?

While we have all heard the rumours that in the future air travel will not be something for 'the masses,' the reporting of these type of dramatic disasters certainly dampens people's enthusiasm to roll the dice for a week or two in a warmer clime - as tempting as that might be at the tail end of another cold Canadian winter.

Yet the question remains, are there really more accidents happening and is it related to 'something' that might be debilitating the pilots, or is it just sensational click-bait to subtly wean us off the desire "to travel the world"?

In an article by Sally Beck published back in November 2023, Sally interviewed Captain Shane Murdock. A former Australian airline captain, Murdock has over 22,000 flying hours experience and holds a Master of Aviation Human Factors qualification for Aviation Investigators, making him one of the most qualified people of the subject of pilot health and safety. In the interview Captain Murdock said that the air industry is 'poised on the precipice of disaster'.

A pilot for more than 40 years, Captain Murdock has found official data that backs up his claim of impending global catastrophe. "When correlated, the data indicates there is an enormous problem that is having, and will have, a



significant impact on aviation safety worldwide. There is enough evidence to be sending out red flags” he said back in 2023.

According to a Lioness of Judah substack post, pilots are super-fit so why are so many dying suddenly or collapsing? Captain Murdock concludes they are suffering severe adverse reactions to the Covid-19 vaccine, which has myocarditis (heart inflammation), brain fog, insomnia, blood clots and anaphylaxis as side effects.

He thinks some pilots are ticking time-bombs and claims many are not declaring ill-health. He said: “They are not reporting brain fog, heart flutters and dizzy spells because they don’t want to lose their jobs.”

Aviators have comprehensive annual health checks and the rules state they can pass only with a less than 1 per cent chance of suffering an illness that could incapacitate them. The question is, how are they passing medicals if they are suffering serious adverse reactions?

One such reason could be the fact that just last year the global aviation regulator, the Federal Aviation Administration (FAA), changed the electrocardiogram (ECG) markers that measure a pilot’s ‘PR interval’. This is the time it takes for an electrical impulse to travel from one part of heart to another and is an indicator of heart health. The new limit is now 50% longer than the previous limit. This means that if a pilot has developed a heart condition, it could easily go undetected.

In November 2020, Australian airlines mandated Covid-19 vaccines for all of their 900 pilots, (as well as all air and ground crew). Of these 900 pilots only 12 refused and were subsequently charged with “serious professional

misconduct” and were all fired. Captain Murdock, who was one of these brave twelve, has been tracking the issue of declining pilot health and the consequential risk of mid-flight ‘mayday’ emergency calls.

Captain Murdock believes that the spike in pilot health issues and the rise in mid-flight emergency calls can have only one result. He is unequivocal and back in late 2023 he said:

“Disasters will occur and both aircrew and the traveling public will die unnecessarily.”

When pilots put out a mayday radio call to air traffic control, it is nicknamed a ‘squawk’. They use the code 7700 for all mayday calls which are reserved for serious incidents like pilot incapacitation or an uncontained fire on board. Few scenarios warrant a mayday, but when they do, passengers and crew face genuine peril.

‘Coincidentally’ since the enforcement of the vaccine mandates there has been an unprecedented rise in the number of mid-flight mayday calls. Between 2018, and 2019, the global mayday average was 29.1% of all distress calls. During 2022, these mayday calls increased by 272% and in just the first three months of 2023, their increase was 386%. The graph above shows there was an instant, steep increase from the exact point in time when the vaccines were mandated for pilots.

According to Covid Medical News in their ‘Special Edition: Senior Pilot Report’ they conclude that there is an “impending disaster in the global aviation industry” and that the “Covid-19 injectables into pilots are a disaster in the making.”

Unfortunately this means we are likely to see more mayday emergencies due to pilot incapacitation and more otherwise ‘inexplicable’ pilot error accidents.

ELECTROMAGNETIC RADIATION - Part 1: Is ‘Digital Dementia’ Behind The Surge Of ADHD In Children?

In our February 22 edition we listed some of Robert Kennedy Jr.’s priorities to ‘Make America Healthy Again’, which, of course, we hope will also ‘Make Canada Healthy Again,’ which is really our mantra at Canada Health Alliance.

These listed priorities included removing glyphosate and other poisonous weedkillers from the food chain (which we covered last week) and the huge health risk of electromagnetic radiation, or ‘EMF’s’ as they are otherwise known.

At CHA we have been very concerned about electromagnetic radiation for a long time, and through this newsletter we have been raising awareness about this little known health risk, especially for children, for several years now.

It was primarily due to this concern that we have partnered with a very reputable shungite supplier to be able to offer a significant discount to our paid CHA members. The American Medical Association has recently revealed something that all parents need to know: Digital devices are causing what scientists call “digital dementia” - the deterioration of brain function in children, sometimes as young as six or seven, depending on their level of exposure to cellphones, iPads and other electronic devices.

The study found that children who use digital devices for more than two hours a day are at high risk of developing ADHD symptoms as a result of the extraordinarily high amount of electromagnetic radiation (or ‘EMF’s’) that these devices emit.

The reason why this is happening is because a children absorb a great deal more EMF radiation than adults. This is because children have thinner skulls and their brains are still in the developmental stage which makes them more vulnerable.

The American Medical Association findings are just one of many studies showing how EMF radiation emitted from digital technology affects kids. There are others which show that premature exposure to EMFs can lead

to a fourhanded percent increased risk of children developing brain tumours.

Most parents are oblivious to this danger, and the withholding of information seems to be intentional. As revealed in a February 25 article published by Children's Health Defense, the NIH refuses to reveal nearly 2,500 pages of records related to the National Toxicology Program's (NTP's) decision to shut down its research on how wireless radiation affects human health. This decision to censor their findings is shocking, especially as the NTP's own 10-year \$30 million study, completed in 2018, found "clear evidence" of cancer and DNA damage caused by electromagnetic radiation, especially in children.

According to their website, the NTP is an "interagency program composed of, and supported by" the U.S. Food and Drug Administration (FDA), the Centers for Disease Control and Prevention (CDC) and the National Institute of Health (NIH). All of these departments now fall under Robert F. Kennedy Jr., Trump's newly appointed Secretary of Health and Human Services.

Kennedy has vowed to get to the bottom of why the health and wellbeing of our children has collapsed so dramatically over the last decade, and what role things like vaccines, weedkillers and electromagnetic radiation play in the surge of chronic conditions that is impacting all American's, especially children.

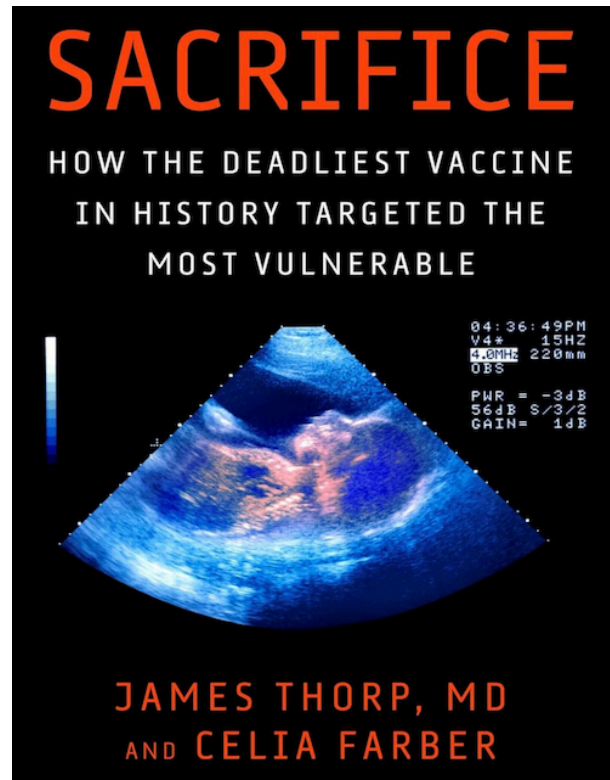
