

Wins of the Week



With everything else going on at the moment we've been a bit distracted researching recent wins, but here are a few which show that beneath all the drama and distractions, things are still slowly but surely moving in the right direction...

 As of last week there are now seven states in the USA that have filed criminal referral requests against Anthony Fauci and other top Covid officials. These states are Arizona, Florida, Louisiana, Missouri, Oklahoma, Pennsylvania and Texas. Other (most likely Republican) states are expected to follow shortly as the chorus of millions of people suffering vaccine injury start to gain their voice and their political momentum. This

- newly forming national lobbyist group are accusing Fauci and other federal health leaders of "murder, assault, abuse and medical terrorism over their mandated, and obviously extremely harmful Covid policies."
- 2) After decades of denial, deflection, and derision, the US executive branch—through the Environmental Protection Agency (EPA) has formally opened a federal inquiry into geo-engineering activities carried out by a private company, Make Sunsets. This opportunistic organization has been injecting sulphur dioxide into the sky to enable them to sell 'cooling credits'! The inquiry issued this Monday by the Office of Air and Radiation, demands detailed disclosures on the company's deployment of sulphur dioxide into the atmosphere-a controversial solar radiation modification (SRM) tactic long derided as conspiracy when spoken aloud by the public. Yet now the EPA and the US Executive Branch are at last taking it seriously, and this is likely just the beginning as 'Make Sunsets' is just one of many, many operators involved in polluting our skies and our air as they interrupt the natural balance of our global weather systems for short term financial gain. According to Saver Ji. "This inquiry follows the growing executive-level momentum where leaders like RFK Jr. are signalling an end to unaccountable, corporate-backed atmospheric experimentation."
- 3) Free Now Foundation has launched a massive legal attack on California's mandated shots required for children to attend schools, either public or private, pre-school, even day care, by filing a lawsuit against the California Department of Public Health on behalf of four named children who were either excluded from their schools on account of their immunization status or are currently threatened with such exclusion and all other Californian children. The goal of the lawsuit is to get rid of California's requirements for any children to get any shots in order to attend school, leaving it up to the parents to decide. If this works in California, we need to apply the same approach to Ontario where literally thousands of school children have been suspended over the last few months for not

- having their vaccine certificates fully up-todate.
- There has also been a victory for common sense in the United Kingdom (which is rare these days with Keir Starmer seemingly hellbent on destroying British culture and its once well-grounded traditions). On Wednesday judges of the UK Supreme Court unanimously ruled that a woman is defined by biological sex under their equalities law. This will end the crazy '600 genders' philosophy of the wokists, at least in Britain. However, hopefully once we have a new government in place in Canada, we can follow the UK Supreme Court's decision on this issue. Isn't it tragic that these days we need to have a national Supreme Court confirm what is so plainly obvious to the rest of us! It is also very telling that after the French Debate on Wednesday evening when Mark Carney was asked by Juno News how many genders there are, and he was unable to answer.
- 5) A judge in Australia has issued a decision dealing an unprecedented blow to the transgender industry's "gender-affirming" model for children. In his landmark ruling, Justice Andrew Strum awarded sole custody of a 12-year-old boy to his father in order to stop the boy's mother's relentless push with the aid of a leading "gender clinic" to "transition" her son through the use of harmful puberty blockers. This could signal a return to common sense and justice for child safeguarding in Australian courts.

The Latest On The Risk vs. Benefit Analysis and 'More Medical Madness'

Over the last six months we have seen a seemingly endless tsunami of white papers, research findings and peer-reviewed studies all of which confirm the unimaginable degree of harm caused by the Covid-19 vaccines and boosters since their hurried launch at the beginning of 2021.


propagandists concerned with money and power more than the health and well-being of citizens.



Between 2020 and 2022 the Rate of Autism In 8 Year Olds Increased by More Than 16%!

Having just had autism awareness month we are all aware of the surging rate of autism in North America and just last week in this newsletter we were looking at how autism has increased from one in every 10,000 children back in 1970 to one in every 1,000 in 1995 to 1 in every 36 children in 2020.

This cataclysmic explosion in autism tracks very closely with the increase in the number of vaccines that children have been subjected to since the 1970's, which is exactly the focus of Robert Kennedy Jr.'s investigation to answer the question as to why this happening.

Well, earlier this week a new study on Autism was published in the CDC's Morbidity and Mortality Weekly Report (MMWR) and it is shocking. This updated report which is based on data collected in 2022 shows that the average rate of autism in the United States in 2022 had increased by a staggering 16% just between 2020 and 2022, making it now one case in every 31 children. This is one of the fastest increases over just two short years that we have ever seen, and makes RFK Jr.'s research into the true cause of this calamity all the more urgent.

So what changed between 2020 and 2022 that could have caused this shocking spike? Did they add more mercury to the childhood vaccines? Did they add more glyphosate to the food supply or more fluoride to the water? Or perhaps did they add a scary new vaccine that these kids were forced to take...? Mmmmm... I wonder...



According to the results of this research study, "Among children aged 8 years in 2022, Autism spectrum disorder (ASD) prevalence was 32.2 per 1,000 children (one in 31) across the 16 sites across the USA where the research was conducted.

These sites range from California being the worst with an average of 53.1 cases of autism per 1,000 children, to Texas where the rate was just 9.7 cases per 1,000 children." It is interesting to compare this to the degree of uptake of the childhood vaccine schedule in these two states, which is significantly higher in California compared to Texas.

Autism was found to be 3.4 times more prevalent among boys (who have 49.2 cases per 1,000 boys) than girls (who just had 14.3 cases per 1,000 girls). Overall, ASD prevalence was lower among non-Hispanic White children (at a rate one 27.7 cases per 1,000) than among Asian or Pacific Islanders (who have a rate of 38.2 cases per 1,000, which is the highest of all the racial categories), American Indian or Alaska Natives (at 37.5 cases per 1,000), non-Hispanic Black or African Americans (at 36.6 cases per

1,000) and Hispanics and Latinos (at 33 cases per 1,000).

In his excellent Focal Points substack post, Nicholas Hulscher notes that, "While we await the results of the intensive research efforts by HHS to determine the causes of this epidemic, abundant evidence suggests that childhood hypervaccination, aluminum vaccine adjuvants, and pesticide exposure serve as risk factors for autism."

If the only thing that RFK Jr. manages to accomplish in his time as Secretary of HHS is getting to the bottom of what is causing this terrible scourge, and in doing so, reduce the rate of autism per thousand children, all his efforts will have been worthwhile and (hopefully) he will be remembered as a hero forever.

Will Canada Face A Drug Shortage Due to the China / USA Trade War?

Unfortunately the short answer is a definite 'Yes!'

Last Tuesday at a Republican fundraising dinner, Trump said, "We are going to be announcing very shortly a major tariff on pharmaceuticals." On the back of that announcement China has retaliated, this time apparently simply withholding critical drug supplies which they are now delaying in bureaucratic red tape and extra 'regulations.'

As a result Canada will no doubt be facing a drug shortage and will very likely see a huge spike in drug retail prices kicking in almost immediately, especially on any drugs coming in via the United States due to the tariff war between Trump and Xi that just continues to escalate, all in the wrong direction.

The latest move in this high stakes brinkmanship is that over the last few days China has started to essentially "hold America's drug supply hostage." Having monopolized the drug manufacturing market almost completely over the last twenty years they are extremely well positioned to leverage this as an extremely painful bargaining chip against the Trump administration. And it has been a long time coming when you consider that the last US plant manufacturing the penicillin antibiotic closed in

2004, which was more than twenty years ago now.

According to a post published by Dr. Peter McCullough on his Focal Points substack, "The Trump administration may face a problem because the US FDA and Department of Commerce allowed China to undercut generic drug prices and allow the exit of pharmaceutical manufacturing to China.

We should be prepared for drug shortages which will be reflected as increased prices. Because the GPO's operate on margin, expect certain drugs for hospitalized patients will be "out of stock" and more expensive ones will be offered."

This anticipated spike in drug prices (especially the more cost effective 'generic' drugs which have historically been more affordable) will be extreme and will no doubt cause significant pain and hardship for people as they have to either find options or simply go without.

However in the longer term, it will force a rapid re-establishment of drug production in the United States, which is ultimately Trump's bigger picture goal. He has been campaigning against the outsourcing of everything including critical 'national security' manufacturing to China ever since the 1980's. Since then he has also been raising the alarm that China can not be trusted

and is open about their aspirations to eventually wrestle world economic dominance away from the Americans.

Way back in 2019 Fox News reported that, "Experts are warning America has become too dependent on China for its medicine – everything from painkillers, to antibiotics, and even aspirin can all be sourced back to a country the Department of Defense considers an adversary. The Food and Drug Administration estimates that at least 80 percent of the active ingredients found in all of America's medicines come from abroad – primarily China.

"Imagine if China turned off that spigot," said Rosemary Gibson, author of "China RX: The Risks of America's Dependence on China for Medicine." "China's aim is to become the global pharmacy to the world – it says that. It wants to disrupt, to dominate, and displace American and other Western companies."

In 2015, China unveiled "Made in China 2025," a national plan to make it the world's leader in 10 high-tech manufacturing sectors, including bio-medicine, by 2025. The new national security warning comes as China is threatening to weaponize its dominance in mining rare earth minerals against the United States, in an escalation of the ongoing trade war."

And this was reported a full six years ago, at a time when no-one was paying any real attention to this clear vulnerability! We are now in 2025, the year China said it would dominate global high-tech manufacturing including biomedicine, so we can't be surprised that with the rising tariff tension they are "turning off that spigot."

While many people in Canada and the United States are bracing for this next financial hit, there are some independent media outlets who can see the longer term benefit of bringing manufacturing back to continental North America. Plus, they are also seeing the, perhaps unintended, benefit of getting people to stop taking as many drugs as they have in the past, which in many cases have a very negative compounding effect on our overall health and wellbeing.

In a news story on America's VoiceLive on Tuesday the news anchor said, "Thank God we have someone FINALLY trying to correct the problem [of over-dependence on hostile foreign countries] in this administration with regards to the lesson about depending on other countries for our most important products. The truth is that

America could actually make drugs in the US, like aspirin. Yet we can't make aspirin?! But, as I always say, nothing is all bad and nothing's all good. When you read stories of elderly (and other younger people as well of late) on 25 different drugs a day and wondering why they feel terrible – until a smart doctor takes them off of all but one or two and they suddenly feel good again, so maybe a drug shortage is a good thing. Passing drugs out like candy at Halloween isn't good for anyone."

At Canada Health Alliance we definitely agree that people in North America are generally 'over-dosed' with pharmaceutical drugs which can lead to unanticipated reactions that trigger conditions which lead to yet more drugs being prescribed. It is a vicious circle which benefits Big Pharma at every turn, yet leaves people in a drug-induced stupor which destroys their productivity, dulls their personality and suppresses their vibrancy and happiness.

The obvious way of getting around these rising costs is to use locally produced Canadian natural health products (NHP's) which generally have far less negative side-effects (if any!) and, by the fact that they are produced in Canada (by Canadians for Canadians), they do not have any tariffs applied to them. Yet Health Canada is doing everything it can to drive up those costs as well.

QAccording to the NHPPA (the Natural Health Products Protection Association), "Health Canada's Self-Care Framework threatens to make essential wellness options and natural health products unaffordable, especially for seniors, families, and lower-income Canadians who depend on them most. By imposing massive fees and costly compliance demands on manufacturers, the government is driving up consumer prices and turning trusted natural health products into a luxury few can afford."

This is a completely unnecessary 'double whammy' at a time of extreme economic volatility when people are reeling from soaring prices impacting everything that will push another great swathe of our struggling middle class into poverty. And our current government is actively making the problem even worse. It is these types of things that need to be taken into account when we go to the ballot box in just nine days time.
