FOLLOW THE MONEY: **The FDA Approves Yet Another Covid Jab For ‘Emergency Use’ – But There’s NO Emergency & The Variant It Is Targeting Is No Longer Dominant!**

So many medical policies, decisions, protocols and products nowadays seem to be made, not in the interests of those subject to them, but to the shareholders of the corporations that develop them!

Just before the end of August 2024 we saw another glaring example of this when the US Food & Drug Administration approved a new Covid-19 vaccine for babies as young as six months old. This was, once again, done through ‘emergency use’ authorization, even though we no longer have any actual emergency. Instead they are citing unsupported claims that it will reduce hospitalizations and deaths.

According to a report in Rebel News, the FDA say that this updated formula will “more closely target currently circulating variants and provide better protection against serious consequences of Covid-19, including hospitalization and death,” but the evidence supporting that is negligible and researchers have repeatedly sounded the alarm that prevention of hospitalization or death wasn’t the studied endpoint in clinical trial outcomes.

However the real issue is that a vaccine which hasn’t been properly trialed and researched can only be distributed and used if a legitimate emergency is declared and in place. With regard to Covid-19, President Joe Biden ended the national emergency in the US more than a year and a half ago. Nonetheless, the FDA has granted emergency use authorization for these ‘updated mRNA Covid-19 vaccines (a 2024-2025 formula)’ from Moderna and Pfizer, that apparently features a ‘monovalent component’ targeting the ‘Omicron variant KP.2 strain.’

And of course we have learnt long ago that flu viruses mutate so quickly that usually by the time a new Covid vaccine is available on the market the variant it was designed to target has waned and is no longer relevant. And that is exactly what has happened with this new vaccine: While the KP.2 variant was dominant back in mid-May, as of August 17 the dominant variant is now the KP.3 and KP.3.1.1 variants which will be unaffected by this new ‘emergency use only’ vaccine!



So why the desperation to get this essentially out-of-date vaccine to market? We can only conclude it is to keep pumping up the profits for Pfizer and Moderna on the back of public panic.

As always, our advice is DON'T take it! There is no 'emergency' and the variants it is designed to target have already been superseded by new ones that will be unaffected by this updated Covid vaccine formula.
